MEMORANDUM OF UNDERSTANDING

BETWEEN

THE FEDERATION OF EGYPTIAN INDUSTRIES

AND

THE FEDERATION OF INDUSTRIES OF GREECE

This Memorandum of Understanding is entered into force between the Federation of Egyptian Industries, hereinafter referred to as FEI, located in Cairo, Egypt and the Federation of Industries of Greece, hereinafter referred to as SBE, located in Thessaloniki, Greece.

Whereas it has been established that there exists great mutual interest in trade and economic development of the private sector of the contracting parties and that it is the fostering of such mutual interest that is most desired for the benefit of all parties concerned;

and

Whereas FEI and SBE, each representing the private sector from its side and believing firmly in the system of private initiative for economic development,

it is therefore agreed between FEI and SBE that the contracting parties will:-

1. Take the initiative to exchange trade, market and economic information and to disseminate to the entrepreneurs of both sides information on goods, services and partnership possibilities that may be available from either or both countries;
2. Provide local assistance to the representatives of the other Party in all matters of this MoU;
3. Notify each other of and assist each other in participating in trade exhibitions, fairs and similar events promoting the products of their countries;
4. Promote and organise visits of trade and industrial missions between the two Parties to extend partnership in their two countries;
5. Organize, as appropriate and where possible, meetings and seminars in both countries to inform businessmen about possibilities of investment, joint ventures and advantageous trade opportunities for both countries;
6. Take all such steps as may be necessary and feasible to promote trade and economic co-operation between the two countries of the Parties;
7. Hold joint meetings when possible and necessary during the course of implementing the MoU.

This MoU shall enter into force on the date of its signing by the representatives of both Parties concerned and shall remain valid for three years, with automatic renewal, unless written notice of termination is given by one Party to the other no less than three months before the date of expiry.

In order to achieve the above objectives, the Parties can use all the services provided to businesses by the Enterprise Europe Network (EEN) of the Federation of Industries of Greece. Through the EEN, company members of the Parties can receive individualized advice on access to international markets and the exploitation of business opportunities internationally, participation in business missions and meetings, organization of events, workshops and conferences on boosting entrepreneurship, extroversion and business competitiveness.
